

**ZIPLOC® BACK TO SCHOOL INSTANT WIN GAME**  
**OFFICIAL RULES**

**NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT INCREASE AN ENTRANT'S CHANCES OF WINNING.**

**OPEN ONLY TO ELIGIBLE LEGAL RESIDENTS OF THE FIFTY (50) UNITED STATES, THE DISTRICT OF COLUMBIA, AND PUERTO RICO WHO ARE AT LEAST EIGHTEEN (18) YEARS OF AGE AT THE TIME OF ENTRY. VOID WHERE PROHIBITED OR RESTRICTED BY LAW.**

The Ziploc® Back to School Instant Win Game (the "Promotion") is sponsored by S.C. Johnson & Son, Inc. ("Sponsor"), 550 W. Washington, Suite 1400, Chicago, IL 60661, and is administered by Prize Logic, LLC ("Administrator"), 25200 Telegraph Road, Suite 405, Southfield, MI 48033. KiwiCo, Inc. is not a Sponsor of the Promotion.

- 1. PROMOTION TIMING:** The Promotion begins on July 1, 2019, at 12:00 PM (noon) Eastern Time ("ET") and ends on September 30, 2019, at 11:59:59 PM ET ("Promotion Period"). The Administrator's computer is the Promotion official clock.
- 2. ELIGIBILITY:** This Promotion is offered only to legal residents of the fifty (50) United States, the District of Columbia, and Puerto Rico, who are at least eighteen (18) years old at the time of participation. Employees of Sponsor, Administrator, KiwiCo, Inc., and each of their parent, subsidiary, affiliated and related entities, and any of their respective owners, parent companies, affiliates, directors, subsidiaries, franchisees, representatives, advertising, promotion and production agencies, agents (collectively, the "Promotion Entities"), and their immediate family members (*i.e.*, spouse, parent, child, sibling, and the "steps" of each) and persons living in the same household of each are not eligible to participate in the Promotion. Void where prohibited or restricted by law. All federal, state, and local laws apply.

Participation constitutes entrant's full and unconditional agreement to these Official Rules and Administrator's decisions, which are final and binding in all matters related to the Promotion. Winning a prize is contingent upon fulfilling all requirements set forth herein. Entrants and/or potential winners may be required to provide proof of identification and eligibility as required by Administrator. For purposes of the Promotion, an entrant's residential address and e-mail address will be the physical address and e-mail address submitted at the time of registration. Entrants will not be allowed to change their physical addresses or e-mail addresses. If it is discovered or suspected that an entrant has registered or attempted to register for the Promotion using multiple e-mail addresses or multiple identities, all of that entrant's game plays will be declared null and void and any prize an entrant might have been entitled to win will not be awarded and may be revoked. Use of any automated system or any like methods to participate in the Promotion is prohibited and will result in disqualification of any entrant attempting such use.

- 3. HOW TO PARTICIPATE:** There are two (2) way to participate in the Promotion:
  - A. Qualifying Purchase and Receipt Upload:** An entrant may, during the Promotion Period, purchase two (2) eligible Ziploc products (Ziploc bags or containers) in the same transaction (see Appendix for list of eligible products) in-store from a participating retailer ("Qualifying Purchase"). **Purchases made at BJ's or Sam's Club are not eligible.** Digital receipts are not eligible for this Promotion. During the Promotion Period, an eligible entrant

must visit <https://national.winziplocstem.com> ("Website") and enter his/her valid e-mail address. If it is the entrant's first time at the Website, the entrant must provide the required registration information, which may include, but is not limited to, his/her first and last name (no initials), street address (no PO Boxes), city, state, ZIP code, daytime telephone number, and date of birth. During the Promotion Period, an entrant may follow the instructions on the Website to upload an image of the Qualifying Purchase receipt. The entrant may then follow the on-screen instructions to play the instant win game and receive one (1) game play ("Game Play"). Each Qualifying Purchase receipt may only be used once. **A Qualifying Purchase receipt must be dated during the Promotion Period to be valid. Any Game Play made using a Qualifying Purchase receipt dated outside of the Promotion Period will be voided and not eligible to win a prize.** The file containing the receipt image must be in .JPEG, .JPG, .PNG, or .GIF format (no PDFs will be accepted) and may not exceed 8 MB. There is a limit of one (1) unique receipt upload per entrant per day during the Promotion Period. An entrant may not submit the same receipt more than one (1) time. Digital receipts will not be accepted. Duplicated receipts will not be accepted. Receipts must be readable. Mechanical reproductions, altered receipts or unreadable receipts will not be accepted. Receipts submitted in excess of the limits set forth herein will not be accepted.

- B. No Purchase Code Request: Between June 15, 2019 through September 15, 2019,** an eligible entrant must legibly hand write his/her full first and last name, complete street address (no P.O. Box), age, and valid e-mail address on a 3½" x 5" properly stamped postcard and mail it to: The Ziploc Back to School Instant Win Game - Code Request, P.O. Box 251328, West Bloomfield, MI 48325. Requests sent in an envelope will not be accepted. Mail-in requests must be postmarked between June 15, 2019 and September 15, 2019 and received by September 25, 2019. Administrator will send one (1) game play code ("Code") by e-mail to the e-mail address provided on each request within seven (7) days of receiving a request. Each entrant may obtain no more than one (1) Code per day (as determined by the name and email address on each postcard), total, through this method of Code request. Mail-in requests will not be returned and no further correspondence will be entered into. Mail-in requests must be original and hand-written. No mechanical reproductions are allowed. **Between September 16, 2019 and September 30, 2019,** an eligible entrant may use the free Code 7Z9P3CSF. Upon receiving a Code, an eligible entrant must visit <https://national.winziplocstem.com> ("Website") and enter his/her valid e-mail address. If it is the entrant's first time at the Website, the entrant must provide the required registration information, which may include, but is not limited to, his/her first and last name (no initials), street address (no PO Boxes), city, state, ZIP code, daytime telephone number, and date of birth. Entrant may follow the on-screen instructions at the Website to enter a Code and receive one (1) Game Play.

Following a Game Play, an entrant will receive notification on the Website screen as to whether he/she is a potential winner ("Notification"). An entrant who receives a winning Notification will be deemed a potential winner subject to verification of the entrant's eligibility and compliance with these Official Rules, **including verification of entrant's Qualifying Purchase receipt (if applicable)**, as determined by Sponsor in its sole discretion. **If an entrant who entered by means of a purchase receives a winning Notification but his/her receipt is not valid, he/she will not be a winner and the prize will be forfeited.** An entrant is not a winner of any prize, even if the Notification should so indicate, unless and until entrant's eligibility and the potential winning Game Play have been verified and entrant has been notified that verification is complete. Sponsor will not accept screen shots or other

**Special Offer of Monthly Ziploc® STEM activities:** During the Promotion Period, upon uploading a valid receipt or entering a valid Code, each entrant will have access to unlock activities on the Website. Each month during the Promotion Period (July, August and September 2019), four (4) new and different Science Technology Engineering and Math (STEM) projects developed by Kiwico ("Monthly Projects") will be made available to every entrant by means of a link. An entrant may click the link and follow the instructions to unlock activities within the calendar month he/she uploads a valid receipt or enters a valid Code, and may upload a valid receipt or enter a valid Code (and therefore get a link for more Monthly Projects) in more than one (1) month during the Promotion Period. No purchase required to unlock STEM activities.

**Note:** If an entrant uses a mobile device to participate in the Promotion, data rates may apply. Not all mobile device providers carry the service necessary to participate. Entrants should consult their wireless providers' pricing plans. In the event that a household enters the Promotion using more than five (5) unique e-mail addresses, all of the Game Plays associated with that household (determined by Sponsor or Administrator in their sole discretion) may be disqualified.

#### **4. PRIZES, APPROXIMATE RETAIL VALUE ("ARV"), AND ODDS OF WINNING:**

**A. Prizes (460):** Each winner will receive a one (1) year subscription to KiwiCo Crates awarded as a digital KiwiCo code (each a "Prize"). The approximate retail value ("ARV") of each Prize is \$205. The total number of Prizes in this Promotion will not exceed four hundred sixty (460). Codes expire September 30, 2019. The Kiwico product lines that are eligible to redeem include Tadpole, Koala, Kiwi, Tinker, Doodle and Atlas.

**B. Total ARV:** The total ARV of all prizes available in the Promotion is \$94,300.

**C. Odds of Winning:** The odds of winning depend on when the entrant completes a Game Play. Prizes will be made available at random times throughout the Promotion Period. To be a potential winner, an entrant's Game Play for a specific Prize must have occurred either at the exact randomly predetermined winning time for that specific Prize, as determined by Administrator.
